Revised Third round of Counseling for the vacant seats of MD/MS/Post MBBS DNB(In-service Quota) Course at ANIIMS for the Academic Year 2025-26 is scheduled on 07th February,2026

Applications are invited for the **Third Round of MD/MS Counselling** for admission to **MD/MS /Post MBBS DNB (In-service Quota)courses** at **ANIIMS** for the **Academic Year 2025-26** is scheduled on **07th February,2026**.

Eligibility criteria

- Candidates should be Citizen of India AND should have undergone MBBS course including the entire Compulsory Rotatory Medical Internship (CRMI) period AND qualified in NEET PG 2025 and score as per the latest notice issued by NBEMS dated 13.01.2026 (minimum of marks at General Category/EWS- 07th percentile and above and SC/ST/OBC/PwD category -0th percentile and above) and General Category/Pwd- 05th percentile and above are eligible for MD/MS/Post MBBS DNB seats.
- Candidates opting MD/MS in State Quota must serve in the Islands for at least one year and have to furnish undertaking in 100rs non-judicial stamp paper failing which he/she will be required to pay Rs10lakhs as penalty.
- Post MBBS DNB through In-service quota shall mandatorily have to serve the Andaman & Nicobar Administration for a period of at-least 10 years on completion of their course
- The duration of the MD/MS/ Post MBBS DNB Broad Specialty is three years
- The Upper age limit for applying for DNB courses In-service quota is 50 years of age

Eligible and interested candidates are requested to apply for the **left over vacant seats**.

- ii. The **06 MD/MS State Quota seats and three In-service DNB seats** will be filled through counselling conducted by ANIIMS

Eligibility for MD/MS State Quota Seats:

- i. Only NEET-PG 2025 qualified candidates who are residents of Andaman & Nicobar Islands are eligible for the 06 State Quota seats.
- ii. The seats will be allotted to candidates with a combined merit among local students (Category I- Tribals, Category IIIA-Settlers who were settled prior to 1942, Category IIIB-those who were settled under various rehabilitation schemes introduced after the reoccupation of Islands and Category IV- Other locals who have had 10 years education in the Islands).

Eligibility Criteria for Post MBBS DNB In-service Quota

- i. Candidate must be a **Citizen of India**.
 - ii. Must have completed **MBBS including entire CRMI AND served at least two years of continuous service** under the **A&N Administration AND qualified NEET-PG 2025**
 - iii. Candidates opting for **Post MBBS DNB under In-Service quota** must **serve A&N Administration for at least 10 years** after completion of the course.
 - iv. Course duration:
• **Post MBBS DNB – 3 years**
 - v. Selected candidates must produce **No Objection Certificate (NOC)** & Permission Order during counselling.
 - vi. **Upper age limit: 50 years.**
- iii. The candidates should report with original certificates and Demand Draft or UTR Number for Electronic Fund Transfer through NEFT / RTGS for the prescribed tuition fee and other fees as specified herein below:-
 - iv. i) Candidates without original certificates / documents shall not be allowed to take admission in the allotted Medical College.

- i. ii) Candidates who have deposited their original certificates / documents with any other Institute / College / University and report for admission stating that “the original certificates are deposited with the respective Institute / College / University” shall not be allowed to take admission.
- v. Every student should pay the tuition fee and other fees, as prescribed by the University, within the due date notified.
- vi. Part payment of tuition fee and other fees are not permitted.
- vii. No extension of time will be given for the payment of fees (or) submission of original certificates under any circumstances.
- viii. At the time of admission, the candidates and their parent / guardian should sign the declaration form / undertaking in Annexure declaring that they agree shall abide by rules and regulations of the University including Anti-Ragging regulations of the UGC / NMC and observe the good conduct & behavior and they are bound by the University rules on payment of fees / refund.

III. **MODE OF PAYMENT OF FEES:**

- a. All the selected students will be required to pay the full fee at the time of counselling /Provisional admission. The fee will be payable in the form of Demand Draft, drawn in favour of “ANIIMS, Admission” payable at **Canara Bank, DHS Building, Sri Vijaya Puram or UPI available. Fee will not be accepted by cash or by cheque.** The admission will only be confirmed after the deposition of full fee. If a candidate fails to deposit the full fee on stipulated time, his/her admission will stand cancelled and the seat will be offered to the next candidate in order of merit in the same category.

VI. Bond of Service

Students getting admission to ANIIMS Sri Vijaya Puram will be required to serve in the Islands for at least one year and have to furnish an undertaking to this effect (**Appendix A**) and will sign a bond on a non-judicial stamp paper of Rs. 100/- as per (**Appendix B**) that, he will serve the Andaman & Nicobar Administration for a period of one year, failing which he/she will be required to pay Rs.10,00,000/- (Rupees ten lacs only) for the default. Additionally, he/she will be

required to sign an undertaking to the effect that he/she will not leave India upto a period of five years from the date of obtaining the degree, otherwise he/she will have to pay Rs.10,00,000/- (Rs. Ten lakhs only) as penalty.

VII. Legal Jurisdiction

All disputes pertaining to the admission to ANIIMS shall fall within the jurisdiction of competent Court, at Sri Vijaya Puram only. The Competent Authority shall be the legal person in whose name the Andaman & Nicobar Administration may sue or may be sued.

If any time being changes/modifications /directions are received from the Government of India / Andaman & Nicobar Administration, then only the latest updates will prevail in the entire prospectus.
