CIRCULAR

Andaman Lakshadweep Harbour Works, Port Blair, a subordinate organization under the Ministry of Shipping, New Delhi enlists contractors, who intend to work with the Department. The objective of such enlistments is to have a ready tist of suitable and competent contractors for the works to be executed by the department, so as to minimise the requirement of verification of credentials of contractors at the time of inviting individual tenders. Besides, only those contractors shall be allowed to continue in the list that remain active in the department and perform well. It shall not confer any right on him either to obtain tender documents or to get a work awarded to him. The Department may add any condition while inviting a tender and as such enlistment of a contractor only entitles him/her to be considered for issuance of tender papers subject to the fulfillment of conditions that may be prescribed in each notice inviting tender.

The set of rules being followed now for enlistment of contractors in ALHW came into force with effect from the 1st day of November 2004. Since then, from time to time, the cases of fresh enlistment & revalidation/ up gradation of the enlisted agencies in ALHW in respective classes under Civil, Mechanical & Electrical category, based on the said rules are being done on regular basis. As per the delegation of power revised by Ministry of Shipping vide letter no:PD/25013/4/2014-MI. Dtd:03.03.2015, the delegation of power need to exercised at circle officer in order to bring more transparency and to keep pace with the overall development /smooth functioning of the department & to facilitate timely enlistment of agencies ,renewal/up gradation of their enlistments as targetted, it is felt necessary to modify these rules by delegating enhanced powers to the Deputy Chief Engineers of the respective circles for settlement of such cases as identified in Table-1(Amended) and such enlistment shall be done in the categories and classes mentioned therein.

The rules being modified on account of renewed authority under various jurisdictions for enlistment/revalidation of contractors in ALHW in respective classes under Civil, Mechanical & Electrical category shall come into force with immediate effect. However, the contractors already enlisted on the basis of the

existing rules shall continue to enjoy the status of enlisted contractors of ALHW till the period of such enlistment, including revalidation/extension granted before coming into effect of this modification. All other matters and further revalidation/up gradation of their enlistment shall be governed by the modified rules.

Applications received for enlistment/revalidation /up gradation upto the date of issue of this amendment & all such cases which are yet to be finalized shall be processed on the basis of modified rules and such agencies shall have to satisfy the minimum eligibility criteria specified in Table-1, before they can be considered for enlistment. The jurisdiction in which contactors are enlisted in various categories and classes shall be permitted to tender and the tendering limit upto which they shall be eligible to tender shall be as given in Table-1(Amended). The contractor shall be governed by the provisions existing at a particular point of time irrespective of which he /she was enlisted.

Therefore in exercise of the powers delegated at Para 25.0 under revision of rules in the "Rules for Enlistment of Contractors in ALHW 2004", CE&A (ALHW) desires to restructure /modify the same as illustrated below.

- 1. Considering the constraints involved in securing departmental works of the required magnitude of Rs. 2.00/Rs.1.00 Lakhs and owing to the inadequacy of works in the department ,it is seen that the agencies enlisted in ALHW in Class "F"(Civil / Mechanical/Electrical) fall themselves to be considered for upgradation /revalidation of their enlistments as the basic eligibility criteria for up gradation/revalidation of enlistments of contractors is to secure ,execute & complete required number & magnitude of works in the respective classes/category. Therefore the existing provision of class/category of enlistment in ALHW is modified as follows.
- a) The enlistment in Civil & Mechanical category shall be in Class 'A', 'B', 'C' 'D'& 'E' only. The value of work falling within the limits of class "F" are very few and generally the small works can be carried out by drawing special imprest by Divisional officers as such the Class "F" of enlistment in Civil & Mechanical category stands abolished. The contractors presently enlisted in class 'F' in Civil & Mechanical category shall be upgraded to Class'E' by virtue of this revision (OR) on receipt of mandatory documents stipulated in Table-1 (Amended) which is enclosed.
- b) The enlistment in Electrical category shall be in Class 'A', 'B', 'C' & 'D' only. The Class "E" of enlistment in Electrical category stands abolished. The contractors presently enlisted in class 'E' in Electrical category shall be upgraded to Class'D' by virtue of this revision (OR) on receipt of mandatory documents stipulated in Table-1(Amended) which is enclosed.

- The Deputy Chief Engineer's within their jurisdiction are delegated with the powers to settle cases of fresh enlistment/revalidation/up gradation of enlistments in ALHW as detailed below.
- a. AT PORT BLAIR. The 'Deputy Chief Engineer(Mech) by virtue of delegation of enhanced powers as stipulated in Table-1 (amended) is empowered & shall be responsible for settlement of all cases of enlistment / revalidation/up gradation for Class 'B','C' 'D'& 'E' only in Mechanical category & for Class' B','C' & 'D' only in Electrical category at Port Blair.

b. <u>AT PORT BLAIR</u> - The Deputy Chief Engineer-I by virtue of delegation of enhanced powers as stipulated in Table-1 (amended) is empowered & shall be responsible for settlement of all cases of enlistment / revalidation/up gradation

for Class 'B', 'C' 'D'& 'E' only in Civil Category.

- c. <u>AT OUTSTATIONS</u> -The respective Deputy Chief Engineer's by virtue of delegation of enhanced powers as stipulated in Table-1 (amended) is empowered & shall be responsible for settlement of all cases of enlistment / revalidation/up gradation for Class 'B','C' 'D'& 'E' only in Civil & Mechanical Category & for Class' B','C' & 'D' only in Electrical category as well.
- 3. The applicant/agency seeking fresh enlistment/revalidation/up gradation of enlistments in ALHW shall download & submit the same with relevant/valid documents to be considered for fresh enlistment, Up gradation / revalidation of enlistments. The set of rules / application form for enlistment of contractors in ALHW 2004 are available in the departmental website http://alhw.and.nic.in. The enlistment application shall be disposed of with 30 days and any insufficient document shall be communicated to applicant within 10 days with a time limit of 10 days to submit.
- The settlement of all cases of enlistment related to the enlisted agencies of Class "A" (Civil/Mechanical/Electrical) in ALHW shall be finalized & settled by the competent authority, i.e, Chief Engineer & Administrator (ALHW).
- 5. All other provisions contained in the said "Rules for Enlistment of Contractors in ALHW 2004" shall remain unchanged.
- A copy of the enlistment order shall be sent to the Office of the Chief Engineer & Administrator & also to all other circle offices. The list of enlistment shall be uploaded in ALHW official website and updated every quarter.


