The Entrance Test (ANIPMT 2015) will be held on **Sunday, 02 August 2015** at notified centers of Andaman & Nicobar Islands.

For selection to the MBBS degree course, The Director, ANIIMS Port Blair shall be the Competent Authority.

The application form for ANIPMT 2015 will be available at the office of the Director, ANIIMS Port Blair, Office of Deputy Commissioner, Car Nicobar, Nicobar District and notified branches of Syndicate Bank.

The syllabus of ANIPMT 2015 is same as **SSC course of CBSE**. The admit card will be issued from the office of Director, ANIIMS Port Blair.

After declaration of result/merit list, specified number of candidates will be called for counselling/admission and document verification.



#### 1. INTRODUCTION:

The long awaited dream of the Andaman & Nicobar Islanders has come true. The Administration is on the verge of starting a New Medical College named Andaman & Nicobar Islands Institute of Medical Sciences (ANIIMS).

#### 1.1 Andaman and Nicobar Islands:

The Andaman & Nicobar Islands is a Union territory, with Port Blair as its capital. The Islands - a total of 572 in number - are located in South-East of the Bay of Bengal, between 6° and 14° North latitudes and 92° & 94° East longitudes. For administrative purposes, the Islands in the Union Territory are grouped into three districts viz. North & Middle Andaman, South Andaman, and Nicobar.

#### 1.2 Location:

Andaman Nicobar Islands Institute of Medical Sciences (ANIIMS) is the new and the only MCI permitted Medical College of Andaman & Nicobar Islands (Union territory). It is situated at Atlanta Point, near Cellular Jail Complex, Port Blair, South Andaman District, Andaman and Nicobar Islands.

#### 1.3 Essence of Medical College:

A & N Islands are situated about 1200 Km. from the mainland. The population of the Islands, as per the last Census is 3.80 lakh. A Medical College in the Andaman and Nicobar Islands gives distinct boost to the health care standards of Andaman and Nicobar Islands with available increased number of medical professionals and advanced health care infrastructure. A well run Medical College in perfect ambience and salubrious climate of Andaman and Nicobar Islands will provide in addition a competitive flair to the lucrative medical tourism.

#### 1.4 Andaman & Nicobar Islands Institute of Medical Sciences (ANIIMS)

Andaman & Nicobar Islands Institute of Medical Sciences (ANIIMS) is a premier Medical Council of India permitted Medical Institute established by Andaman & Nicobar Medical Education and Research Society (ANIMERS) under Andaman & Nicobar Administration. ANIMERS is chaired by the Lt. Gen. A.K. Singh PVSM, AVSM, SM, VSM (Retd.), Honorable Lieutenant Governor of Andaman & Nicobar Islands. The Executive Council of the Institute is presided by the Chief Secretary, A & NAdministration.

#### 1.5 Mission

The primary aim of the Institute is to provide state of art medical services, quality medical

education and research in Andaman & Nicobar Islands. The Institute being the only Medical College in this region is committed to uplift the health care delivery system for the people of these Islands. The Institute is scheduled to start its academic session from 2015-16 with 100 seats of which 85% are reserved for the students of Andaman & Nicobar Islands. The institute has been permitted to admit students by Medical Council of India vide Ministry of Health and Family Welfare.

#### 1.6 Director:

Maj Gen (Dr) R. P. Choubey, VSM (Retd) is the Director of ANIIMS. He is a medical graduate from KGMU, Lucknow, and postgraduate from AFMC, Pune. He did his post-doctoral training in Gastro-intestinal surgery from AIIMS, New Delhi, and was a visiting fellow at Liver Transplantation Centre, Queen Elizabeth hospital, Birmingham, UK. He has served in the Armed Forces Medical Services for over 35 years. He was conferred Vishisht Seva Medal for his meritorious service by the President of India. He is a member of Association of Surgeons of India, Indian association of Surgical Gastroenterology, Association of Armed Forces Surgeons of India and Indian Chapter of International Association of Hepatobiliary surgery.

#### 1.7 Departments:

The ANIIMS has all the pre-clinical, para-clinical and clinical departments with associated GB Pant Hospital. The pre-clinical and para-clinical departments have internet and Wi-Fi facility and are well equipped with labs, demonstration rooms, dissection hall, seminar rooms, departmental library and research labs.



#### 2. Ragging

Andaman and Nicobar Islands Institute of Medical Sciences is a ragging free campus. Ragging in any form is strickly probhited and any student found to be involved in the practice to be ragging will be liable to severe disciplinary action

#### 2.1 Raging includes any or all of the following:

- Mental / Physical / Sexual abuse
- Verbal abuse
- Violation of decency
- Criminal intimidation/ wrongful restraint
- Under mining human dignity
- Financial exploitation/ extortion
- Use of Criminal force

- 2.2 Astudent indulging in ragging can be disciplined as under:
  - Expelled from institution
  - Banned from Mess/Hostel
  - His/her scholarship can be withdrawn
  - Debarred from examination
  - Criminal prosecution
- 2.3 All students admitted to Andaman and Nicobar Islands Institute of Medical Sciences, Port Blair and their guardians are required to sign an undertaking that their ward will desist from indulging in ragging as per **Appendix A Part I & II.**

#### 3. MBBS COURSE

#### 3.1.1 Duration of the course

The course of studies leading to the award of Degree, "Bachelor of Medicine & Bachelor of Surgery" (MBBS) shall be a minimum of 41/2 yrs followed by one year compulsory rotatory internship.

#### 3.1.2 Professional Examination

In order to be eligible for appearing in the professional examination each student of MBBS Programme must meet the attendance requirement both in Theory & Practical's /Seminars/ Presentations etc as laid down in MCI guidelines.

#### 3.2.3 Number of seats

There will be 100 seats for MBBS programme at Andaman & Nicobar Islands Institute of Medical Sciences, Port Blair for the academic session 2015-16.

#### 3.1.4 Reservation & Allocation of Seats

The allocation of seats in Andaman and Nicobar Islands Institute of Medical Sciences Port Blair is given below in the table. However, there may be changes depending upon the direction of the Govt of India/Andaman and Nicobar Administration which shall be notified on the ANIIMS website <a href="http://andssw1.and.nic.in/ANIIMS">http://andssw1.and.nic.in/ANIIMS</a> and institute notice board before start of counselling/admission.

#### # RESERVATION FOR PHYSICALLY HANDICAPPED PERSON

As per Graduate Medical Education Regulation 1997 and Amendment Notification No. MCI- 34(41)/2008-Med./ 54469 Dated 25th March 2009, and MCI guidelines letter No.MCI-34(1)/2003- Med/11773, dated 14/7/2003 following is the criteria for reservation under Physically Handicapped Category.

"3% seats of the annual sanctioned intake capacity shall be filled up by candidates of any category with locomotory disability of lower limbs between 50% to 70%, provided that in case any seat in this 3% quota remains unfilled on account of unavailability of candidates with locomotory

disability of lower limbs between 50% to 70% then any such unfilled seat in this 3% quota shall be filled up by persons with locomotory disability of lower limbs between 40% to 50% - before they are included in the annual sanctioned seats for State Quota candidates.

The Candidate with a disability more than 70% will not be eligible for admission to MBBS Course. No other disability shall be allowed as per the MCI regulations. However, such a candidate will be required to undergo medical examination by a Special Medical Board constituted for this purpose by the Competent Authority. The Special Medical Board will ascertain and certify the disability and will also ascertain and certify that he/she is physically fit to undergo the course despite the disability.

Verification of the disability will be carried out by Special Medical Board constituted for this purpose by Competent Authority and decision of the Special Medical Board shall be final. The date and place of Special Medical Board shall be communicated by the way of notification.

3.2. The various categories as specified in Para 3.1.4 can be claimed by attaching the Certificate as per appendices detailed below.

#### 3.2.1 (Category-I) Tribals

Certificate as per **Appendix B** duly signed by Tehsildar of the Jurisdiction to be attached to support your claim

3.2.2 (Category-II) Wards of Central Govt. Employees & those on Deputation with transfer liability

Central Government Employees & those on deputation with transfer liability to serve outside the Union Territory, provided their wards have studied the last two years in the Islands and passed the qualifying examination from a school in the Islands. Certificate as per **Appendix C** duly signed by the competent authority of the concerned department, to be attached to support your claim

- 3.2.3 (Category-III) Pre 1942 Settlers & those who were settled under various rehabilitation schemes introduced after reoccupation of Islands. Certificate as per Appendix D duly signed by the tehsildar of the jurisdiction, to be attached to support your claim
- 3.2.4 **(Category-IV)** Wards of locals & Central Govt. Employees (Who do not fall under Category I, II or III) having no transfer liability to serve outside the Union Territory, provided their wards have had 10 years education in the Islands. Certificate as per **Appendix D** duly signed by the competent authority of the concerned department, to be attached to support your claim
- 3.2.5 (Category-V) General merit quota opens to all resident of Andaman and Nicobar Islands subject to condition that their wards should have studied the last 02 years in the Islands and passed the qualifying examination from the school of the Islands. Class XII

#### Certificate to be attached to support your claim

#### 3.2.6 Reservation for Physically Handicapped Candidates.

Three seats for physically handicapped persons will be filled on the basis merit from any category. The candidates will be required to submit a valid disability Certificate from competent Authority issued not more than 03 months prior to counselling / admission. The certificate as given in **Appendix E** must indicate the nature and extent of physical disability as per the guidelines of Medical Council of India. No certificate other than this shall be accepted for claiming the physically handicapped seats. Provided that if the seats reserved for physically handicapped remains unfilled due to non availability of eligible candidate(s) under this category, the same shall be treated as unreserved.

#### 3.2.7 Other backward class candidates

OBC candidates claiming relaxed eligibility criteria as indicated in para 4.5 and 6.2 must submit a certificate as per **Appendix F** duly signed by Tehsildar of the jurisdiction.

#### 4. ELIGIBILITY FOR ADMISSION TO MBBS DEGREE COURSES

4.1 The candidate must be an Indian National.

- 4.2 The candidate must be born on or before 31st December 1998 to be eligible to appear for ANIPMT-2015. The Birth certificate indicating name of the candidate, Secondary School Certificate i.e. SSC or equivalent examination certificate or School Leaving Certificate endorsing the date of birth will constitute a valid proof.
- 4.3 The candidate must be medically fit except those applying under Physically handicapped category and must submit a certificate of medical fitness at the time of Admission as per **Appendix G**.
- 4.4 Candidates who seek admission under different categories should strictly satisfied the conditions mentioned in para 3.1.4.

#### 4.5 Eligibility criteria of Qualifying Examination for MBBS:

Acandidate must have obtained not less than 50% marks in Physics, Chemistry and Biology taken together at the SSC (or equivalent) Examination. A candidate belonging to constitutional reservation i.e. SC / ST / OBC and and person with Disability claiming constitutional reservation must have obtained not less than 40% marks in Physics, Chemistry and Biology taken together at the SSC (or equivalent) Examination. Person with Disability in General category must secure not less than 45% marks in Physics, Chemistry & Biology (PCB) taken together at the SSC (or equivalent) Examination.

4.6 Eligibility criteria of Competitive Examination (ANIPMT) for Admission to MBBS Course:

Acandidate must secure not less than 50% marks in Physics, Chemistry & Biology (PCB) at Pre Medical Test i.e. ANIPMT-2015. A candidate belonging to constitutional reservation (SC, ST & OBC) and constitutional reservation with Person with Disability (PWD) must secure not less than 40% marks in Physics, Chemistry & Biology (PCB) in the ANIPMT-2015. Person with Disability in General category must secure not less than 45% marks in Physics, Chemistry & Biology (PCB) in the ANIPMT-2015.

#### 4.7 Cut-off date for the eligibility:

The eligibility of the candidate shall be determined and/or decided for all purposes including for applicability of all these Rules and Regulations by considering the last date of submission of Application Form as the cut-off date. It is made abundantly clear that if a candidate is found ineligible as on the last date of submission of Application form, in terms of these Rules and Regulations, and if such an ineligible candidate acquires the requisite eligibility after the aforesaid cut-off date (i.e. the last date of submission of Application form), such subsequent acquisition of eligibility will not make an ineligible candidate eligible for any purpose whatsoever, much less for the purpose of admission.

#### 4.8 Penalty for lapse of seat (MBBS Course):

Any candidate responsible for lapse of MBBS seat will have to pay a penalty of Rs.10,00,000/- (Rupee Ten Lakhs Only). This penalty is applicable to all those candidates who do not join after taking admission or cancel a seat after last round of admission. This penalty is also applicable to the candidate resigning a seat after cutoff date for MBBS course i.e. 30<sup>th</sup> September, 2015 or fails to complete the course. If admission is cancelled on medical grounds after cut-off date, the Competent Authority will take appropriate decision regarding 'waiving off' penalty, after ascertaining medical grounds by special medical board, constituted by the Competent Authority. Surety bond as per **Appendix H** to be submitted at the time of counseling/admission.

#### 5. ANIPMT - 2015 (Andaman and Nicobar Islands Pre Medical Test)

#### 5.1 ANIPMT-2015

The entrance examination for the selection to MBBS degree Course in Andaman and Nicobar Islands Institute of Medical Sciences, Port Blair for the academic year 2015-2016 shall be conducted by the Competent Authority appointed by the Andaman Nicobar Administration. The Competent Authority shall devise the system of Counseling and Selection. This procedure shall be governed by regulations and directions specified by the Andaman Nicobar Administration from time to time.

#### 5.2. Definitions

5.2.1 "Appeal Committee" means the Committee setup under the chairmanship of the Competent Authority; it shall deal with the representations submitted by the

candidate(s)/parent(s) relating to grievances of the candidates with regard to ANIPMT-2015 examination and the selection process.

- 5.2.2 "Competent Authority" means the Authority designated or appointed by Andaman Nicobar Administration to conduct ANIPMT- 2015, and declare the results. The Competent Authority will supervise and control the selection process for the admission to MBBS degree courses and act as a chairperson of the Appeal Committee for representations submitted by the candidates. The Competent Authority will issue necessary executive instructions for implementation and provide relevant information to be published or communicated.
- 5.2.3 "Sub-Centre In charge" means the officer in charge of the High School / Senior Secondary School / College, where the ANIPMT-2015 examination is being conducted.

#### 5.3. **Scheme of Examination**

- 5.3.1 Date of Examination: The examination will be conducted at various centers in Andaman and Nicobar Islands on **Sunday**, **02 August 2015**.
- 5.3.2 Schedule & Test Design: The ANIPMT-2015 will consist of one question paper Containing 180 Multiple Choice questions (MCQ), each Carrying 1(One) mark and total marks 180. The distribution of number of questions and marks in Physics, Chemistry and Biology (Zoology & Botany) is as under:

There shall be no choice among the questions, i.e. all questions have to be answered. The candidate desirous of selection to MBBS courses should appear for ANIPMT 2015. The Candidates will be provided with one OMR Answer Sheet and Question Booklet. At the end of the examination, candidate will hand-over the Answer sheet and Question booklet to the invigilator. No candidate is allowed to leave the examination Hall till the end of examination.

5.3.3 The candidate will be required to mark the correct answer by blackening the corresponding circle against the serial number of the question in the answer sheet with black ink ballpoint pen only. Out of four circles provided for selection of an answer against a question, the candidate should fill up one circle only. Each correct answer will be given 1 (one) mark. There will be **no negative marking**. Candidates giving multiple answers for a question will be awarded zero (0) mark.

**CHANGING AN ANSWER IS NOT ALLOWED**: The candidates must fully satisfy themselves about the accuracy of the answer before darkening the appropriate circle, as no change in the Answer once marked is allowed. The answer once marked is final, any change in the option once marked, done by any method, will amount to a invalid/incorrect response.

- 5.3.7 Language of Question Paper: The medium for examination shall be English.
- 5.3.8 Examination Centre:

The ANI PMT-2015 will be conducted at various notified sub-centers in Port Blair.

6.3 Preparation of Merit list and Declaration of Result

The list of qualified candidates in different categories will be displayed separately on the institute website <a href="http://andssw1.and.nic.in/ANIIMS/">http://andssw1.and.nic.in/ANIIMS/</a> and notice board. No separate intimation to the candidates will be sent.

6.4 Preparation of Merit List for Selection to MBBS Course.

As per Marks obtained by the candidate at the ANIPMT-2015 a category wise merit list, will be prepared.

6.5 Tie-breakers In case of equal corrected marks at the ANIPMT-2015, the following procedure shall be adopted for deciding inter-se merit,
