Pursuant to the Letter of Permission given by the Ministry of Health and Family Welfare, New Delhi (Ref.1), Inspection Report dated 26.09.2015 (Ref.4), submission of Compliance Report, Undertaking and funds remitted (Ref.6), the approval of the University is hereby conveyed for starting a new Medical College in the name of *Andaman & Nicobar Islands Institute of Medical Sciences* at Port-Blair with provisional affiliation to offer MBBS course with an annual intake 100 seats for the academic year 2015-16, subject to continuation of approval by MCI/GOI and ratification by AC/EC of the University.

The College should fulfill all the affiliation conditions as stipulated in our letter dated 18.11.15 (Ref.5) and as undertaken to comply with, in the undertaking submitted in your letter dated 02.12.2015 (Ref.6) and other affiliation conditions stipulated in the annexure to this letter.

The observations of the Inspection Committee that have been agreed to be implemented should be complied without any compromise and the final compliance shall be informed before **31st January 2016**.

All faculty positions should be filled up without existence of any vacant position as per UGC/MCI norms and the appointments should be made on permanent and full time basis in the presence of University nominee.

All changes in the teaching staff and other changes that may affect the fulfillment of the conditions for affiliation should be reported to the University within a fortnight.

Request for University nominee for appointment of faculty shall be sent to the University at least one month in advance.

The Advisory Committee meeting should be conducted at regular intervals as per norms with University nominee in the Advisory Committee and minutes submitted to the University.

The Management of the institution shall discharge the statutory duties relating to pension, gratuity, provident fund etc., for its employees.

Surprise checks will be conducted, to ensure that whether all the compliances reported have been actually taken care of.

In case of violation of any of the conditions of the University, the affiliation would be withdrawn and the college alone would be responsible for all consequences in this regard. In such an event, the affiliation fund would stand forfeited to the University.

This provisional affiliation shall be valid only for a period of one academic year i.e. 2015-16. Admission of students for the next academic year i.e. 2016-17 should not be made/done without approval of the Medical Council of India and valid affiliation from the University.


