Pursuant to the inspection report dated 05.05.2017 (Ref.3), funds remitted (Ref.5) and  
compliance verification report (Ref.6) approval of the University is hereby accorded for  
provisional affiliation for UG course in Andaman & Nicobar Islands Institute of Medical  
Sciences, Port-Blair **for the academic year 2017-18** subject to MCI approval and recognition  
and also subject to ratification by AC/EC of the University and the following conditions:

- ✓ 1) Stage/date of completion of the construction work of exam. hall, lecture hall and  
hostel building should be informed to the University.
- 2) Blood bank license and B.M.W license should be renewed and the copy should be  
submitted.
- 3) Biometric machine installation should be communicated.
- ✓ 4) Copy of the MCI recognition order for M.B.B.S course for the academic year  
2017-18 should be submitted. If recognition for the academic year 2017-18, is not  
granted by MCI this provisional affiliation stands cancelled.

The observations made by the Inspection Committee that have been agreed to be implemented vide your letter dated 12.06.2017 should be complied. ✓

All faculty positions should be filled up without existence of any vacant position as per UGC/MCI norms and the appointments should be made on permanent and full time basis in the presence of University nominee.

All changes in the teaching staff and other changes that may affect the fulfillment of the conditions for affiliation should be reported to the University within a fortnight.

Request for University nominee for appointment of faculty shall be sent to the University atleast one month in advance.

**The Advisory Committee meeting should** be conducted at regular intervals as per norms with University nominee in the Advisory Committee and minutes submitted to the University.

The College shall strictly follow the UGC Guidelines/Regulations 2009 on curbing the menace of ragging in Higher Educational Institutions (Under Section 26 (I) (g) of the University Grants Commission Act 1956).

The **Sexual Harassment Prevention Committee** should be constituted as per UGC regulations 2015.

**Insurance, Fire Service NOC, Groundwater user license and PPA permit should be renewed periodically.**

The Management of the institution shall discharge the statutory duties relating to pension, gratuity, provident fund etc., for its employees.

Admission of students should be made strictly in accordance with GOI/GOA&N/ University norms. Admission of students should be made within the stipulated date as prescribed by MCI and Pondicherry University in its academic calendar.

Excess admission of students over and above the approved intake will not be entertained by the University under any circumstances.

Admission of students should not be made to the courses for which there is no affiliation.

Surprise checks will be conducted, to ensure whether all the compliances reported have been actually taken care of. In case of violation of any of the conditions of the University, the affiliation would be withdrawn and the college alone would be responsible for all consequences in this regard. In such an event, the affiliation fund would stand forfeited to the University.



This provisional affiliation shall be valid only for a period of one academic year i.e. 2017-18. Application for provisional affiliation for renewal of affiliation for the academic year 2018-19 should reach before 7<sup>th</sup> January 2018.

Admission of students for the next academic year i.e. 2018-19 should not be made/done without the approval of the Medical Council of India and valid affiliation from the University.
