Tender documents, excluding standard form, will be issued from the office of the Indira Bhawan, Municipal Council, during the hours specified above, on payment of the following:

- Rs.500.00 (Rupees Five Hundred Only) (Non-refundable) in cash as cost of tender document
- Earnest Money of (as indicated above) in Receipt Treasury challan/deposit at call receipt of a Scheduled Bank/ Fixed Deposit Receipt of a Scheduled Bank/Demand Draft of a Scheduled Bank, issued in favour of the Executive Engineer (Water Works) Municipal Council.
- The intending bidder must satisfy himself/herself about eligibility to participate in the bidding process prior to submission of bid.
- The bid submitted by ineligible bidders/incomplete bids/bids without EMD or other mandatory documents, will be summary rejected and will not be included in the Comparative Statement for the purpose of arriving lowest bid etc.,
- Tenderer/Authorized representative of the Tenderer should be present at the time of opening of tender with proper authorization letter.
- The tender along with enlistment copy, Pan Card Copy and Proper Postal Address with Telephone numbers and earnest money shall be placed in separate sealed envelopes each marked 'Tender' and 'Earnest Money' respectively and submitted together in another sealed envelopes. In case where earnest money in cash is acceptable the same shall be deposited with the Cashier of this Division and the receipt thereof should be placed in the sealed envelope. The envelope marked 'Tender' of only those tenderers shall be opened whose earnest money placed in the envelope is found to be in order.

The Executive Engineer (Water Works) Municipal Council reserves the right to accept or reject any or all the tenders without assigning any reason thereof and also does not bind himself to accept the lowest tender.
