- The bid submitted by ineligible bidders/incomplete bids/bids without EMD or other mandatory documents, will be summary rejected and will not be included in the Comparative Statement for the purpose of arriving lowest bid etc.,
- Tenderer/Authorized representative of the Tenderer should be present at the time of opening of tender with proper authorization letter.
- The tender along with enlistment copy, GST Registration Certificate, Pan Card Copy and Proper Postal Address with Telephone numbers and earnest money shall be placed in separate sealed envelopes each marked 'Tender' and 'Earnest Money' respectively and submitted together in another sealed envelopes. In case where earnest money in cash is acceptable the same shall be deposited with the Cashier of this Division and the receipt thereof should be placed in the sealed envelope. The envelope marked 'Tender' of only those tenderers shall be opened whose earnest money placed in the envelope is found to be in order.
