The tender documents containing the terms and conditions, EMD and other details can be obtained from the Cashier, Directorate of Economics & Statistics, Port Blair on payment of Rs.50/- (Non Refundable) per set on any working day during 9.00 AM to 03.00 PM. Tender documents will be sold upto 03.00 PM on 31.01.2019. The terms and conditions of the tender may also be downloaded from the official website www.and.nic.in/tendersonline of A&N Administration. Such tenders shall accompany Rs.50/- in the Form of Demand Draft in favour of Statistical Officer(HQ) towards the cost of documents. The tender should be placed in the tender box kept in the Establishment Section on or before 03.00 PM on 31.01.2019 and the same will be opened on 31.01.2019 at 03.30 PM in the presence of Tenderers, if any, present at the time of opening of the tender. Terms and Conditions of tenders for the sales of un-serviceable Maruti Omni of Directorate of Economics & Statistics, Port Blair on “as is where is” conditions vide Tender Notice No. 31-8/2012-2016/DES/44 dated 11th January 2019

By entering in the bid, the firm/bidder agrees to the terms and conditions as prescribed below. The firm/bidder shall comply with the terms of the tender and in no case relaxation on any terms shall be applicable, other than stipulated. Tenders without acceptance of terms and conditions, is liable to be rejected.'

The terms and conditions of the tenders are prescribed below for adherence by the bidders.

1. The tender duly sealed and super scribed with “Tender for sale of unserviceable Maruti Omni under the Directorate of Economics & Statistics, Port Blair, Tender No. & Date, Due Date & Time of Opening addressed to the Director of Economics & Statistics, Port Blair should be placed in the tender box kept in the Establishment Section of the Directorate of Economics & Statistics, Port Blair before 03.00 PM on 31/01/2019.
2. The tenderers should quote their rate for the unserviceable Maruti Omni as per details given in the attached schedule. The Tender shall accompany EMD Rs.3,000/- (Rupees three thousand only) as mentioned in the attached schedule in form of Account Payee Demand Draft/Fixed Deposit/Receipt/Bank Guarantee from a Nationalized Bank drawn in favour of the Statistical Officer (HQ), Directorate of Economics & Statistics, Port Blair. Tender submitted without EMD will be rejected.
3. The tender will be opened on 31/01/2019 at 03.30 PM in the presence of the tenderes, if any, in the chamber of Statistical Officer(HQ), Directorate of Economics & Statistics, Port Blair. Delayed and late tenders will not be accepted. In case the date of opening is declared Holiday, the same will be opened in the next working day at the stipulated time and place.

4. The unserviceable Maruti Omni mentioned in the schedule can be inspected on any working days in the Complex of the Directorate of Economics & Statistics, Port Blair with the permission of the Statistical Officer(HQ) during 09.00 AM to 03.00PM on any working day before the date of opening of the tender.
5. The EMD of unsuccessful tenders will be released after the finalization of the tender. The EMD of successful tenderers will be deposited in the Government account and the highest accepted bidder(s) will have to deposit the residual amount after deduction of bid security with the Cashier of this department. Non deposit of residual amount within the stipulated time period may lead to forfeiture EMD.
6. The unserviceable Maruti Omni will be sold strictly on “as is where is” condition. The successful tenderers will have to deposit the residual amount after deducting the bid security with the cashier of this department within 15 days from the date of receipt of communication/ intimation of acceptance of the bid by the department. The Maruti Omni should be removed within 15 days from the date of issue of delivery order. In the event of the failure to deposit the amount and removal of Maruti Omni from the site within the period stipulated above, the EMD will be forfeited to the Government Account and the Omni Van will be disposed off to the best advantage of the Government.
7. The tenderers should furnish their full name, address and Telephone No. for communication. The Department shall not be held responsible for non submission of proper address for communication.
8. The description of unserviceable, for which the tenders are invited, the EMD etc. are given in the attached schedule. The rates should be quoted in the enclosed schedule.
9. Non-adherence of any of the above terms or the tenders submitted by the bidders found incomplete in any respect, may lead to rejection of their bid.
10. If any dispute of difference arises on account of breach or observances, compliance of any of the terms and conditions of tender, the same shall be referred to the Director of Economics & Statistics, Port Blair, as per provisions made under Indian Arbitration Act, who shall appoint an Arbitrator whose decision shall be final and binding on both the parties.
11. Any further dispute shall be subject to jurisdiction of the courts at Port Blair.

12. Torn and mutilated tender shall also be rejected.
13. The Purchase Committee can summarily recommend to the competent authority for rejection of any or all of the bids if the same is found to be incomplete in any respect.
14. In case the total quantity to be disposed off cannot be taken up by the highest acceptable bidder, the remaining quantity will be offered to the next highest bidder(s) at the price offered by the highest acceptable bidder.
15. The Director of Economics & Statistics, Port Blair reserves the right to accept or reject any or all the tenders without assigning any reason thereof.
16. No terms and conditions other than stipulated above will be entertained Tenders without acceptance of terms and conditions, is liable to be rejected.
