Sealed Tenders are invited from manufacturers/dealers/traders for supply of Uniform Saree with blouse for the use of Anganwadi Workers and Helpers working under the five ICDS Projects on the following terms and conditions:

**Terms and conditions:**

1. The rate should be quoted for one Saree with blouse piece.
2. The quality of item should be strictly as per specification, supply of which is to be made in the Directorate of Social Welfare within 21 days from the date of supply order.
3. The quotation should be accompanied with EMD of Rs. 10,000/- (Rupees ten thousand only) in the shape of Call Deposit/FDR drawn from any Commercial Bank in favour of Assistant Accounts Officer, Directorate of Social Welfare, Port Blair.
4. The sealed tender indicating the item should reach this office on or before 28.02.2019 at 3.00 PM and the same shall be opened at 4.00 PM on the same day in the presence of tenderers or representatives, if any.
5. A sample of the specified Saree with blouse shall be submitted separately in a sealed cover subscribing the sample for Uniform Sarees.
6. The tender without sample shall not be entertained.
7. The sample and the price bids shall be placed in separate envelopes and both the envelopes shall be put in one large envelope. The envelope containing the price list should be clearly superscribed with the words Price Bid for supply of item "Uniform saree with blouse".
8. Tenders of only those bidders will be opened whose sample is found suitable by the Committee constituted for this purpose by the Department.
9. The rates shall be valid till 28<sup>th</sup> February 2020 and shall be inclusive of all taxes.
10. The interested parties can inspect the samples kept at ICDS Cell, Directorate of Social Welfare upto 26<sup>th</sup> February 2019
11. The Director (SW) reserves the right to accept or reject any or all Tenders including the lowest tender without assigning any reason thereof.
