**TENDER AND CONDITIONS**

1. Interested parties may submit their highest prices for the said vehicle in sealed cover latest by 3.00 PM on or before 14/12/2020 and on the same day at 3.30 PM it will be opened before the bidders or their representatives, if any. The inner cover containing quotations and other relevant documents along with DD/Banker's Cheque towards EMD should be sealed properly. The sealed cover super scribed in Bold Capital letters '**QUOTATIONS FOR DISPOSAL OF ONE NO. CONDEMNED VEHICLE**' should be addressed to Vehicle Officer, DC Office, South Andaman dropped in the Tender Box.
2. The disposal of vehicle shall be strictly on "**AS IS WHERE IS BASIS**" and no guarantee or certificate of its worthiness or quality will be given by this Department. The condition of the vehicles can be inspected at the District Office, Port Blair on working days between 10.00 AM to 4.00 PM. In this regard the Vehicle In-charge, Deputy Commissioner, District Administration may be contacted. No complaint whatsoever will be entertained after the tender submitted or before or after the vehicle are lifted. No request for inspection after submission of tender will be accepted.
3. The sealed quotations should accompany **Earned Money Deposit for Rs.500/-** in the shape of Demand Draft/Banker's Cheque raised in favour of Sr. Accounts Officer, Deputy Commissioner Office, South Andaman. If the highest tenderer/successful bidder, accepted by the competent authority, fails to deposit the total bid amount within the prescribed time limit, his EMD will be forfeited. Also in case the offer is withdrawn by any tenderer, the EMD deposited by them shall be forfeited. Tenders received without EMD will be summarily rejected.
4. The successful bidder will be required to deposit the total bid amount to the cashier, Deputy Commissioner Office, South Andaman within seven working days of award of the contract.

5. EMD of the successful bidder will be released only after realization of the sale proceed amount. Earnest Money Deposited of the bidder who fails to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this Department.
6. The delivery of the auctioned vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/Voter Identity Card) in case of individual and Registration Certificate in case of firms etc.
7. The auctioned vehicle should be removed by the successful bidder within 48 hours of depositing the money at his expenses. No assistance/transportation will be provided by the department. Permission to take out the auctioned vehicle from the Deputy Commissioner, South Andaman, premises will not be allowed on holidays, and Sundays etc.
8. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
9. The Deputy Commissioner, South Andaman, reserves the right to reject all or any tender/quotation in whole or part without assigning any reason thereof.
10. The bidder is required to reveal his full name/name of the authorized signatory of the firm/name of the father, full postal address, telephone number & mobile number.
11. Disputes, if any, shall be subject to jurisdiction in the Court of Port Blair only.
12. If the highest quoting firm fails to honour the bid, the contract will be cancelled and its EMD forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (H-2 quoting party) to complete the bid provided if he is prepared to accept the prices offered by the H-1 party. In case of any dispute, decision of the Deputy Commissioner, South Andaman shall be final.
13. Tender form should be signed by the authorized signatory only. Photocopy or unsinged quotations not signed by authorized signatory shall be rejected.
14. The firm/individual participating in the tender shall alone be responsible for furnishing any false or wrong information and the consequences or less thereof.
15. Quotation should be offered in Performa prescribed as given at Annexure-I and copy of the document can be obtained from the office.
