- The quotations should be submit through e-Procurement portal only (https://eprocure.gov.in).
- The quotations received after the stipulated date will not be entertained.
- The Earnest Money Deposit (EMD) to the extent of **Rs.6,000**/- in form of Call Deposit drawn in any of the nationalized bank in favour of Joint Secretary (NPCB), Port Blair shall accompany the quotation.
- The quotation received without EMD/call deposit will not be accept.
- The supply of spectacles should be made within 10 days from the date of issue of supply order (alongwith prescriptions), failing which, LD of 0.5% will be recovered for delay upto 10 days and thereafter LD of 1.0% will recover against the total value of supply order.
