## **GENERAL TERMS & CONDITIONS**

1. The sealed tender communicating the rate for cleaning the Sump tank ( 100 ton capacity)and overhead tank( 50 ton capacity)at Fish landing Centre, Junglighat should be submitted at Zonal fisheries Office, South Andaman on or before 03.00 PM on 31/10/2019 . The details of work is at **Annexure - I** The tenders would be opened on the same day at 03.30 PM in the presence of the tenderers or their representatives, if any.
2. The Earnest Money Deposit (EMD) of Rs. 500/- (Rupees five hundred only) in the form of Call Deposit Receipt obtained from any Nationalized Bank drawn in favor of the Asst. Director of Fisheries, Zonal Fisheries Office, Port Blair should be enclosed along with the tender.
3. The Tenderers should submit along with the following:
  - a) PAN/TAN Card
  - b) Bank Account No. details with IFSC and MICR.
4. Tender received after due date and time will not be considered.
5. Qualifying Criteria (Mandatory): -
  - a) Earnest Money Deposit.
  - b) Experience certificate from any Govt. agencies, PSU, Autonomous bodies for having done aforesaid work.
  - c) IT returns for last two years. (, 2017-18, 2018-19)
  - d) GST Regd. Certificate of the firm if applicable.
6. The rate quoted should be written in figures and words including all overhead charges. Cutting and overwriting should be attested by the tenderers.
7. The tenders should be submitted in the format **annexed at Annexure-II** along with this tender document. Tenders submitted in any other format shall not be accepted.
8. No conditions of the Tenderers shall be accepted and conditional tenders shall be rejected.
9. For any clarification the Tenderers may contact the Assistant Director of Fisheries, Zonal Fisheries office, South Andaman on any working day during working hours.
10. The Assistant Director of Fisheries, Zonal Fisheries office, South Andaman reserves the right to accept or reject any or all quotations received without assigning any reason thereof.
11. The In-charge, Fish landing Centre, Junglighat shall inspect the cleaning work during each stage.

## **ARBITRATION**

12. In case of any dispute arising between parties, the same shall be referred to the arbitration of sole arbitrator to be appointed by Lt. Governor, A & N Islands and the place of such arbitration proceedings shall be at Port Blair and the decision of the arbitrator shall be final and binding on both the parties. The matter relating to arbitration shall be governed under the provisions of the Arbitration and Conciliations Act – 1996.

## **EARNEST MONEY DEPOSIT:**

13. The Earnest money deposit or bid security for **Rs.500/-(Rupees five only)** should be paid in the form of Fixed deposit receipt, Call deposit or a Bank Guarantee in acceptable form from any of the Nationalized banks of India.
14. The EMD of tenderers will be forfeited, if the tenderers withdraw or amend its tender or impairs or derogates from the tender in any respect within the period of validity of its tender. Further, if the successful tenderers fail to furnish the required performance security within the specified period, its EMD will be forfeited.

## **PERFORMANCE SECURITY**

15. Within 07 (Seven) days after the issue of acceptance letter by the Asst. Director of Fisheries, South Andaman, the firm shall furnish performance security to the Asst. Director of Fisheries, South Andaman for an amount equal to 10 (Ten) percent of the total value of the contract, and the validity of the Performance Guarantee should not be less than (06) six months, the purchase guarantee shall be valid up to sixty days after the date of completion of all contractual obligations by the firm
16. The Performance security shall be denominated in Indian Rupees and shall be in one of the following forms: Fixed deposit receipt/ Call deposit drawn on any Nationalized Bank in India drawn in favor of cashier, Zonal Fisheries Office, South Andaman, Port Blair.

17. In the event of any loss due to firms failure to fulfill his obligations, the amount of the performance security deposited by the firm shall be forfeited and remitted to the Govt. Account to compensate the loss occurred to this office .
18. Subject to adherence of all terms and conditions, this office will release the performance security without charging any interest to the firm on completion of all contractual obligations including the warranty obligations against a written request received by this office.

**WORK COMPLETION**

19. The successful bidder should complete the work in all respect and to the satisfaction of this office within **10 (ten)** days.
