PRESS NOTE

It is brought to the notice of all consignees and general public that the Director (Sc. & Tech.), Pollution Control Committee, Department of Science and Technology, Dolly Gunj, Port Blair vide letter No. 2-13/PCC/PWN(2016)/EPR/2020/27 dtd. 07.04.2021 has informed that for effective implementation of EPR (Extended Producer Responsibility), it has been decided that a new format for self-declaration Form be used for consignees who are bringing product into the Islands.

The format has been formulated for declaring the product brand and estimated quantity of goods per brand to ensure that no banned plastic item is brought into the Islands.

All consignees bringing products from mainland must submit relevant and accurate information regarding their consignments in the below given format.
