The Cultural organizations shall submit application to this Department in the prescribed format enclosing Utilization Certificate in GFR-12A for the details of GIA released in the previous year alongwith the Audited statement of the last financial year comprising of Receipt & Payment statement, income & Expenditure statement, Balance sheet and Annual report of month-wise activities of the Organization for the year 2022-23 with supporting documents. All Cultural Organizations should also be registered on PFMS portal and NGO-PS Portal (NGO DARPAN): www.ngo.india.gov.in. The PFMS Unique Agency Code, and Unique ID of Darpan Portal to be quoted mandatorily by Organizations in its application.

The Prescribed format may be downloaded from the website www.andaman.gov.in The duly filled in applications should reach the Directorate of Art & Culture, Cellular Jail Complex on or before 15.07.2022.
