
The under mentioned employee of this division has been absenting from government duty since w.e.f. 26/08/2022 to till date and a desertion notice needs to be published in the Dailies.





प्रेस विज्ञापन

श्री. मोहम्मद शफीक, पुत्र श्री. ए. कामरूद्दीन, मजदूर, एम.ई.सी.एच, ऑटोमोबाइल, ब्रकशॉप, रंगत बे, मध्य अण्डमान वन प्रभाग के तहत तैनात अपने कर्तव्यों से अनधिकृत रूप से 26 अगस्त, 2022 से अब तक अनुपस्थित हैं।

श्री. मोहम्मद शफीक, पुत्र श्री. ए. कामरूद्दीन, मजदूर ने एक चिकित्सा सुचना पत्र भेजा है जिसमें कहा गया है कि उनका चिकित्सा उपचार चल रहा है जिसके अनुसार उन्हें 26.09.2022 को अपने कार्य स्थान पर कार्य ग्रहण करना था, लेकिन उन्होंने आज तक अपना कार्य ग्रहण नहीं किया है, उनके द्वारा जमा किए गए चिकित्सा दस्तावेज मुल नहीं है और फोटो प्रतियां/स्कैन की गई प्रतियां शामिल है जो स्पष्ट और उचित रूप से प्रमाणित नहीं है । इसलिए, उन्हें इस परित्याग विज्ञापन के प्रकाशन की तिथि से 05(पांच) दिनों के भीतर आवश्यक चिकित्सा दस्तावेजों/ प्रमाण पत्रों के साथ अधोहस्ताक्षरी को विधिवत प्रमाणित करने के लिए निर्देश दिया जाता है, जिसमें विफल होने पर उनके खिलाफ के औद्योगिक श्रमिकों के लिए लागू स्थायी आदेशों के प्रावधान के अनुसार सी.सी.एस. (सी.सी.ए.) नियम, 1965 के तहत उनके खिलाफ आवश्यक अनुशासनात्मक कार्रवाई की जाएगी ।
