PRESS RELEASE

A&N Islands Khadi & Village Industries Board had published a Press Release in the Daily Telegram dated 09.05.2023 through which applications were invited for the post of Supervisor (Group 'C') and vacancy notice was also published by the A&NI KVIB in the online portal <https://erecruitment.andaman.gov.in> on 09.05.2023. Candidates are hereby informed that the CBT (Computer Based Test) will be held on 6.09.2023 and 7.09.2023. The Hall tickets will be available for downloading from online portal <https://erecruitment.andaman.gov.in> from 17.08.2023 from 11 am onwards. Candidates are advised to download their Hall ticket directly from the portal. The timing, venue and other examination details are available in the Hall ticket.

Any PwBD candidate (Person with benchmark disability) who intends to avail facility of scribe have to contact Executive officer, A&NI KVIB office and submit requisite form on or before 25.08.2023 for opting scribe.

In this regard, the following guidelines for Visually Handicapped (VH) / Cerebral Palsy & Persons with Benchmark Disability (PwBD) shortlisted candidates for computer based examination are given :-

1. The examination will be conducted on CBT mode.
2. Persons with benchmark disability in the category of Visually Impaired(VH), Orthopedically handicapped (afflicted by Cerebral Palsy), Orthopedically Handicapped candidates who has a locomotor disability wherein, the dominant writing extremity is affected to the extent of slowing down the performance of the candidate (such deficiency to be indicated in the certificate, issued by competent authority, submitted by the candidate) will be allowed compensatory time of 20 minutes.
3. Visually Impaired (VH) Cerebral Palsy / Candidates are eligible for Scribe to be arranged by themselves.

4. The VH/CP & PwBD candidate who wish to avail the facility of scribe shall apply for allowing the Scribe addressed to the Executive officer, ANI KVIB latest by 25.08.2023.
5. The candidates shall be responsible for any misconduct on the part of the scribe brought by him during the exam.
6. The Candidate as well as the Scribe will have to give a suitable undertaking in the prescribed format 'Letter of Undertaking for using own scribe.
7. In case, it later transpires that he/she did not fulfils any laid down eligibility criteria or suppressed material facts, the candidature of such applicant will stand cancelled, irrespective of the result of the online examination.
8. The decision of the A&NI KVIB in this case shall be final and binding.
