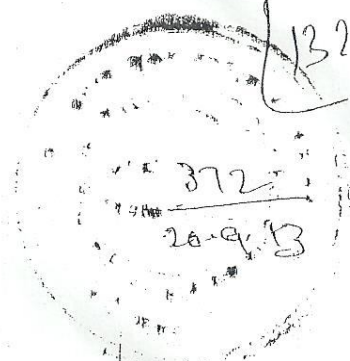

Minutes of the meeting held under the Chairmanship of Chief Secretary on 27/08/2013 in his chamber at 1100 Hrs to decide the issues related to removal of trees hazardous to life and property.

The following Officers attended the meeting.

1. Dr. Shashi Kumar , PCCF, Dept of Environment and forest.
2. Smti Puniya Srivastav, Commissioner-cum-Secretary(PWD).
3. Shri P.K.Singh, Commr-cum-Secretary/Chief Engineer, APWD.
4. Shri Vikas Ahlawat, Sub Divisional Magistrate, South Andaman.

At the outset, the Chairman welcomed all the participants. After due deliberation on the issue, it was decided that if any Sub Divisional Magistrate passes an order under Section 133 CrPC declaring a tree dangerous to life and property, then the following agency/person/department will take necessary action as follows:

- If the subject land on which the said tree stands dangerously belongs to private person, then the Private person himself/herself will cut the said tree.

(Action : concerned private person)

- If such a dangerous tree stands along the road side and building maintained by APWD authority, APWD will take necessary action to remove the said tree.

(Action : APWD)

- Further, if any such tree stands dangerously on a subject land duly allotted to any department /organization the concerned department shall comply the order.

(Action: concerned Department/organization)

- In the last, if such a tree stands dangerously on any Government Revenue Land the respective Deputy Commissioner's office shall ensure.

(Action: concerned Deputy Commissioner)

It was also decided that there is no need to deposit any such tree after its removal to forest irrespective of its nature/type/kind/species of the tree. The concerned agency or person should dispose it as deemed fit.

This has the approval of competent authority.
