
**Directorate of Social Welfare Invites Applications for Assistive Devices for Divyangjan through PMDK-CRC, Port Blair**

Ministry of Social Justice & Empowerment, Government of India, New Delhi, is implementing Pradhan Mantri Divyasha Kendra (PMDK) Scheme at Composite Regional Centre (CRC), Port Blair. In this regard, general public are informed that assistive devices are being provided to eligible Divyangjan/persons with disabilities and senior citizens.
