The Lieutenant Governor (Administrator) Andaman and Nicobar Islands, hereby makes the following amendment in “The A&N Islands Widow Allowance/Pension (Amendment) Rules, 2013”, notified vide notification number F.No. 6-14/DSW/Notification/2013-2014/1120 dated 14-05-2013 namely:-

1. Short title and commencement:

- (i) This scheme may be called “The A&N Islands Widow Pension (Amendment) Rules, 2018”.
- (ii) These rules shall come into force with effect from 01st April, 2018.

- 2.** Rule 7 of the A&N Islands Widow Pension (Amendment) Rules, 2013 shall be substituted as under:-

“The quantum of Widow Allowance shall be Rs. 2500/- per month and the applicant shall cease to receive the assistance if she gets remarried or becomes financially independent afterwards, which may be divulged by due enquiry or through records”.

The Lieutenant Governor (Administrator), Andaman and Nicobar Islands, hereby makes the following amendment in “The A&N Islands Allowance to Destitute Women (Amendment) Scheme-2013”, notified vide F.No. 6-14/DSW/Notification/2013-2014/1119 dated 14-05-2013, namely:-

1. Short title and commencement:-

- (i) This scheme may be called “The A&N Islands Allowance to Destitute Women (Amendment) Scheme 2018”.
- (ii) This scheme shall come into force with effect from 01st April 2018.

2. Rule 7 of the A&N Islands Destitute Women (Amendment) Scheme, 2013 shall be substituted as under:-

“The quantum of Allowance to Destitute Women shall be Rs.2500/- per month and the applicant shall cease to receive the assistance if her monthly income exceeds Rs. 4000/- and or ceases to be a permanent resident of A&N Islands”. The beneficiary shall be required to inform Director (SW) about such change in status immediately i.e. within 15 days. In case of failure to inform within 15 days the Director (SW), shall after due enquiry recover the allowance paid through the Revenue Authorities as arrears of land revenue”.

1. Short title and commencement:

- (i) This scheme may be called "The A&N Islands Disability Allowance (Amendment) Scheme, 2018".

2. Clause 6 of the Andaman & Nicobar Islands Disability Allowance (Amendment) Scheme, 2013 shall be substituted as under:-

The Lieutenant Governor (Administrator), Andaman and Nicobar Islands, hereby makes the following amendment in the A&N Islands Old Age Assistance (Amendment) Rules, 2013 notified vide notification number F.No. 6-14/DSW/Notification/2013-2014/1121 dated 14-05-2013 namely:-

1. Short title and commencement:

- (i) This scheme may be called “The A&N Islands Old Age Assistance (Amendment) Rules, 2018”.
- (ii) These rules shall come into force with effect from 01st April, 2018.

2. Rule 4 of the A&N Islands Old Age Assistance (Amendment) Rules, 2013 shall be substituted as under:-

“Old Age Assistance shall become payable from the month following the one in which it is sanctioned. The amount of assistance for persons in the age group 60-79 years shall be Rs. 2500/- per month, and for persons aged 80 years & above shall be Rs.3000/-, including the beneficiaries of Indira Gandhi National Old Age Pension Scheme (IGNOAPS).
