**PRESS RELEASE**

**SOUTH ANDAMAN POLICE SOLVED MURDER CASE AND ARRESTED  
THE ACCUSED FROM NANDIGRAM, HALDIA, WEST BENGAL**

A special team from PS Aberdeen has made extraordinary efforts to arrest an accused of a murder case, who had slipped away to Nandigram, West Bengal, after pretending to be the well wisher of the deceased lady.

A PCR call was received in the wee hours on 03/08/2017 that a lady had fallen down from motorcycle. The injured was quickly shifted to G. B. Pant hospital, where she was under treatment. Her husband Sheikh Sahil Parvez presented a picture to police and her relatives that he was taking her to her parent's house when she fell down from his motorcycle. However, the truth came forth, when the duty doctor told police about the life threatening injuries and fracture on her cervical bone along with strangulation marks.

On this, a case was registered at PS Aberdeen under sections of attempt to murder and investigation was entrusted to SI M. V. Shiju Kumar, PS Aberdeen.

On further investigation, reliable sources from locality revealed that Sahil had left Port Blair by GoAir flight to reach his native place Amgachia in West Bengal. Further few of his friends were questioned in connection with the case and it was established that Sahil had a turbulent relation with his wife and had intentionally left Port Blair to avoid arrest.

Immediately a special team consisting of SI M.V.Shiju Kumar, HC/910 Vijay Shankar and PC/3015 D. Shiv Kumar was deputed for West Bengal. Upon reaching Nandigram, the team informed the matter to the officer Incharge of PS Nandigram, who alerted the staff of Tekali Bazaar outpost and conducted an extensive search for the accused but Sahil kept on hiding himself for two days. However, due to proper planning and execution, Sahil was intercepted in Amgachia village on 6<sup>th</sup> August and was brought to PS Nandigram for further interrogation.

During interrogation Sahil accepted his guilt and told that on the intervening night of 03/08/17, he had an altercation with his wife, which turned ugly and he tried to strangulate her with her duppatta.

On 06-08-2017, the victim succumbed to her injuries during treatment at GB Pant Hospital. The accused was finally brought to Port Blair and has been remanded to Judicial Custody.

The special team has put in hard work to solve the case and arrest the accused. The entire operation took place under the direction of Insp. A. K. Singh, SHO PS Aberdeen and overall supervision of SDPO (SA) Shri. Nishant Gupta.
