PRESS NOTE

It has been found that even after repeated warnings, many Autorickshaw are found without putting the fare meter on/ refusing to ply/ overcharging of fare from the passengers in various places in Municipal area which is violation of permit conditions and provisions of MV Act/Rules. The following under mentioned vehicle owners were found violating provisions of M.V.Act/Rules.
