

**Terms and Conditions of tenders for the sales of un-serviceable Items of DC Office, Car Nicobar on "as is where is" conditions vide Auction Notice No.2-298/DCN/Condemnation/Board/Unserviceable/2017-18.**

By entering in the bid, the firm agrees to the terms and conditions as prescribed below. The firm shall comply with the terms of the tender and in no case relaxation on any terms shall be applicable, other than stipulated. Tenders without acceptance of terms and conditions, is liable to be rejected.


The terms and conditions of the tenders are prescribed below for adherence by the bidders.

1. The tender duly sealed and super scribed with "Tender for sale of un-serviceable Items' attached to Assistant Commissioner (HQ), Car Nicobar, Tender No. & Date, Due Date & Time of opening addressed to the Deputy Commissioner, Nicobar District, Car Nicobar should be placed in the tender box kept in the Establishment Section, DC office, Car Nicobar before 03.00 PM on **16.11.2018**.
2. The tenderers should quote their rate for the un-serviceable Items as per details given in the attached schedule. The Tender shall accompany EMD of **Rs.1500/- (Rupees One Thousand Five Hundred Only)** as mentioned in the attached schedule in form of Account Payee Demand Draft/Fixed Deposit Receipt/ Bank Guarantee from a Nationalized Bank drawn in favour of the **Project Officer (ITDP), Car Nicobar**. Tender submitted without EMD will be rejected.
3. The tender will be opened on **16.11.2018** at **03.30 PM** in the presence of the tenderers, if any present, in the chamber of AC (HQ), Car Nicobar. Delayed and late tenders will not be accepted. In case the date of opening is declared Holiday, the same will be opened in the next working day at the stipulated time and place.
4. The un-serviceable Items can be inspected on any working days at DC Office, Car Nicobar mentioned in the Schedule with the permission of the Assistant Director (Admn.), DC Office, Car Nicobar during 9.00 A.M. to 3.00 PM on any working day before the date of opening of the tender.



5. The items will be sold strictly on "as is where is" condition. The successful tenderers will have to deposit the residual amount after deducting the bid security with the Cashier of this department within 15 days from the date of receipt of communication/intimation of acceptance of his bid by the department. The items should be removed within 60 days from the date of issue of delivery order. In the event of the failure to deposit the amount and removal of items from the site within the period stipulated above, the EMD will be forfeited to the Government Account and the items will be disposed off to the best advantage of the Government.
6. The EMD of unsuccessful tenders will be released after the finalization of the tender. The EMD of successful tenderers will be deposited in the Government account and the highest accepted bidder(s) will have to deposit the residual amount after deducting the bid security with the Cashier of this department as stipulated at point 5 above.
7. The tenderers should furnish their full name, address and Telephone No. for communication. The Department shall not be held responsible for non submission of proper address for communication.
8. The description of items, for which the tenders are invited, the EMD, etc. are given in the attached schedule. The rates should be quoted in the enclosed schedule.
9. Non-adherence of any of the above terms or the tenders submitted by the bidders, found incomplete in any respect, may lead to rejection of their bid.
10. If any dispute or difference arises on account of breach or observance, compliance of any of the terms and conditions of Tender the same shall be referred to the Deputy Commissioner, Nicobar District, A & N Administration, Car Nicobar, as per provisions made under Indian Arbitration Act, who shall appoint an Arbitrator whose decision shall be final and binding on both the parties.
11. Any further dispute shall be subject to jurisdiction of the Courts at Port Blair.
12. Torn and mutilated tender may also be rejected.

13. The purchase committee can summarily recommend to the competent authority for rejection of any or all of the bids if the same is found to be incomplete in any respect.
14. In case the total quantity to be disposed of cannot be taken up by the highest acceptable bidder, the remaining quantity will be offered to the next highest bidder(s) at the price offered by the highest acceptable bidder.
15. The Tender should possess of registration for Scrap lots comprising of hazardous waste, e-work as per the Guidelines of Ministry of Environment and Forest.
16. In case the selected bidder does not show interest in lifting the goods, the bid security should be forfeited and other actions initiated including re sale of the goods in questions at the risk and cost of the defaulter, after obtaining legal advice.
