SHOW CAUSE NOTICE

Whereas, Shri Anthony Roun, posted in DCF(WL-I) Division as Regular Mazdoor w.e.f. 18.10.2002 attached to Range Officer(Protection) is absenting from 09.09.2005 onwards without any intimation or prior permission from his controlling or superior authority. He has unauthorizedly absenting from duty since 09.09.2005 to till date and thereby violated the provision of Industrial Rules by committing gross misconduct. He has exhibited lack of devotion to duty and acted himself in a manner of unbecoming of a Govt. Servant by violating the provisions of Rule 11 sub rule (e) & (f) and Rule 26 sub rule(vii), (viii), (xiii) and (xiv) of Standing order applicable to Industrial Establishment of Wildlife Division.

And whereas, desertion notice was published vide in “the Daily telegram vide DCF (WL) L.No. LP/WD/253, 1233 & 2567 dated 07.01.2009, 01.09.2010 & 14.12.2015 with the direction to appear before the undersigned and submit valid reason for his long leave for remaining unauthorizedly absent within 15 days from date of publication of the above notices. He had been given ample opportunity to resume his duty but his whereabouts are unknown to anyone, as the above notices served to him as per the addresse produced by him in service book was returned to sender by the postal department stating that “*addressee not found*” or “*refused to receive*”. Accordingly, an article of charge framed against him for remaining unauthorizedly absence from Govt. duty vide this office Memorandum No.INQ/CON/RM/23 dated 31st May 2017. The charge memorandum was served to him through his hometown address the same was returned by the postal department with the remarks ‘*addressee not found*’.

And whereas, Smti R.Barkha, Range Officer was appointed as *Inquiring Authority* and Smti Archana Majumdar, Forester as *Presenting Authority* to inquire into the charge framed against Shri Anthony Roun, Regular Mazdoor vide this office order No. INQ/CON/RM/37 & 38 dated 21.07.2017

And whereas, the Inquiry Authority has conducted the inquiry and submitted the inquiry report to the undersigned vide her letter No INQ/CON/RM/2018-19/631 dated 09.11.2018. As such the charged officer was not present during the course of inquiry the Inquiry Authority has taken the decision to conclude the inquiry *ex-parte (with the witnesses Annexure-III)*.

And whereas, on a careful consideration of the inquiry report, the undersigned has provisionally come to the conclusion that Shri Anthony Roun, Regular Mazdoor is not a fit person to be retained in service and accordingly proposed to impose upon him penalty of dismissal from service.

Now, therefore, Shri Anthony, S/o Roun, Regular Mazdoor is hereby given an opportunity of making representation on the penalty proposed above. Any representation which he may wish to make against the penalty proposed will be considered by the undersigned. Such a representation, if any should be made in writing and submit so as to reach the undersigned without fail on or before 15 days from the date of receipt of this show cause by Anthony, S/o Roun, Regular Mazdoor.

The receipt of this show cause notice should be duly acknowledged.
