Individual call letter alongwith admit card for skill test has been issued to all the shortlisted 46 candidates by post.

If any of the 46 candidates does not receive the call letter alongwith admit card for skill test till 01.09.2019, they are at liberty to submit application addressed to the Chief Administrative Officer, District & Sessions Court, Port Blair on 02.09.2019, 03.09.2019 and 04.09.2019 in between 10.00 am to 3.00 pm for issuance of duplicate call letter alongwith admit card.

The candidates are directed to bring original admit card already issued to them earlier for appearing in the written examination and call letter alongwith admit card issued for the skill test.

The candidates are directed to bring their original testimonials alongwith self attested copies of the same in support of his/her candidature which includes date of birth, education qualification, category etc and Photo Identity Proof for verification. Before skill test original testimonials shall be compared with the self attested copies.

No candidate shall be allowed to appear in skill test (Speed Test in typewriting on Computer) if he/she fails to produce original documents alongwith self attested copies of the same as mentioned above.

No candidates will be allowed to appear for the skill test on Computer, if he/she fails to reach the venue before the commencement of the verification of certificates.

Candidates who will be found disqualified on verification of original testimonials in terms of essential qualifications as published in the advertisement dated 18.09.2017 in the Daily Telegrams, shall not be allowed to appear for Paper-2 examination i.e. skill test on computer.

No candidate shall have choice any particular computer for the skill test. No electronic gadgets or mobile phone will be allowed inside the computer lab or mobile phone shall be allowed inside the computer lab. No TA/DA will be provided.

Examination Authority reserves the right to disqualify any of the candidates to appear in the skill test in appropriate cases without assigning any reason.
