SELECTION NOTICE FOR THE POST OF "CLERICAL ASSISTANT" ON  
DAILY RATED BASIS

The candidates appearing in the Annexure hereto are informed that their names have been sponsored by the Employment Exchange, Port Blair for considering their candidature for the post of **Clerical Assistant on daily rated basis** for working in the Alternative Disputes Resolution Centre (ADR Centre) - 'PRAYAS' under the District Legal Services Authority, Port Blair and that they are required to appear before the Selection Committee in the Alternative Dispute Resolution Centre (ADR Centre) - 'PRAYAS', Port Blair at 04.00 p.m. on 30.06.2015. Individual call letter has been issued to all the candidates.

It is made clear that the selected candidate does have no right to claim for regular employment and that the appointing authority reserves the right to disengage him/her at any time in course of daily rated employment without any notice.

The candidate who may be selected will be paid daily wage as per the minimum wage fixed by the Andaman and Nicobar Administration under the Minimum Wages Act, 1948 as amended in 2004, from time to time and that he/she will be entitled to daily wage only on those days he/she actually works in the office.


They are required to bring with them their certificates and testimonials in original together with self attested Photostat copies thereof, proof of identity (i.e. any photo identity card issued by any authority of government), one passport size photograph and the call letter.
