NOTIFICATION

Port Blair, dated the 10th April, 2012

No. 72/2012/F.No.1-30/2009/DES.— In exercise of the powers conferred by the provision to Article 309 of the Constitution read with the Ministry of Home Affairs, Notification No. U-14039/2/83-ANL dated 21st February, 1985 and in supersession of this Administration's Notification No. 52 dated 12.2.2007, read with UPSC's letter No. 3/30(14)/2010-RR dated 8.3.2012, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, hereby makes the following rules regulating the method of recruitment to the post of Director of Economics and Statistics in the Directorate of Economics and Statistics, Andaman and Nicobar Administration, namely:—

1. Short title and Commencement :-

- These rules may be called the Andaman and Nicobar Administration (Director of Economics & Statistics) Recruitment Rules, 2012.
- They shall come into force on the date of their publication in the Official Gazette.

2. Number of posts, Classification and Scale of Pay :-

The number of posts, their classification and scale of pay attached thereto, shall be specified in paras (2) to (4) of the Schedule annexed hereto.

3. Method of recruitment, Age limit, Qualification :-

The method of recruitment to the post, age limit, qualifications and other matters relating thereto shall be as specified at paras (5) to (13) of the said Schedule.

4. Disqualification :-

No person -

- (i) who has entered into or contracted a marriage with a person having a spouse living, or
- (ii) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Lieutenant Governor, Andaman and Nicobar Islands, if satisfied that such marriage is permissible under the personal law applicable to such persons and other party to the marriage and there are other grounds for doing, exempt any person from the operation of this rule.

5. Powers to relax :-

Where the Lieutenant Governor (Administrator), Andaman and Nicobar Islands is of the opinion that it is necessary or expedient to do so, it may by order and for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of posts or persons.

6. Saving :-

Nothing in these rules shall affect reservations and other concessions, required to be provided for the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

No. 45/2017/F.No.1-30/2012/DES.— In exercise of the powers conferred by the provision to Article 309 of the Constitution of India read with the Government of India, Ministry of Home Affairs, New Delhi's Notification No.U-14039/2/83-ANL dated 21st February, 1985 and UPSC's letter No. 3/30(14)/2010-RR dated 8.3.2012 and in pursuance of Department of Personnel & Training's OM No. AB. 14017/13/2016-Estt.(RR) dated 9.8.2016, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands hereby makes the following Amendments to the Recruitment Rules to Group-A (Gazetted) post of Director of Economics and Statistics in the Directorate of Economics & Statistics, Andaman and Nicobar Administration published in the A & N Extraordinary Gazette Notification No.74 dated 10th April, 2012:-

1. Short tiltle and commencement :-

- (i) These rules may be called the Andaman and Nicobar Administration (Director of Economics & Statistics) Recruitment (Amendment) Rules, 2017.
- (ii) They shall come into force on the date of their publication in the Official Gazette.

AMENDMENTS

Should have undergone training **either** on Senior/Junior Certificate Course in Statistics of minimum 3 weeks duration from the Central Statistical Organization **or** on relevant area such as Computer/Agriculture Statistics/National Accounts Statistics/Social Statistics/ Industrial, Trade & Services Statistics/ Index Number & Price Statistics/ Sample Surveys for a minimum period of 1 or 2 weeks from the National Academy of Statistical Administration.

Note: Where Juniors who have completed their qualifying/ eligibility service are being considered for promotion, their Seniors would also be considered provided they are not short of the requisite qualifying/ eligibility service by more than half of such qualifying/eligibility service, or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade alongwith their Juniors who have already completed such qualifying/eligibility service.

Officers under the Central/ State Govt./ Union Territories:

- (A) (I) holding analogous posts on regular basis in the parent cadre/ department; (OR)
- (II) with 5 (five) years service in the grade rendered after appointment thereto on a regular basis in Level-10 (Rs. 56100-177500) in the Pay Matrix or equivalent in the parent cadre/department; (OR)
- (III) with 6 (six) years service in the grade rendered after appointment thereto on a regular basis in Level-8 (Rs. 47600-151100) in the Pay Matrix or equivalent in the parent cadre/department; (OR)
