# **NOTIFICATION**

Port Blair, dated the 19th March, 2010.

No. 63/2010/F.No.1-30/2005/DES.—In exercise of the powers conferred by the provision to

Article 309 of the Constitution read with the Ministry of Home Affairs Notification No.U-14039/2/83-ANL dated 21<sup>st</sup> February, 1985 and in supersession of this Administration's Notification No. 195 dated 20.9.2006, read with the UPSC's letter No. 3/30(3)/2009-RR dated 26.02.2010, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands hereby makes the following rules regulating the method of recruitment to the post of Research Officer in the Directorate of Economics and Statistics of the Andaman and Nicobar Administration, namely:-

#### 1. Short title and Commencement:

- These rules may be called the Andaman and Nicobar Administration (Research Officer) Recruitment (Amendment) Rules, 2010.
- ii. They shall come into force on the date of their publication in the Official Gazette.

#### 2. Number of Posts, Classification and Scale of Pay:

The number of posts, their classification and the scale of pay attached thereto, shall be specified in paras (2) to (4) of the Schedule annexed hereto.

## 3. Method of Recruitment, Age limit, Qualification:

The method of recruitment to the post, age limit, qualifications and other matters relating thereto shall be as specified at paras (5) to (15) of the said schedule.

# 4. Disqualification: No person -

- (i) Who has entered into or contracted a marriage with a person having a spouse living, or
- (ii) Who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Lt. Governor, A & N Islands, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and there are other grounds for doing, exempt any person from the operation of this rule.

#### 5. Power to relax:

Where the Lt. Governor (Administrator), Andaman and Nicobar Islands is of the opinion that it is necessary or expedient to do so, it may by order and for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of posts or persons.

#### 6. Saving:

Nothing in these rules shall affect reservations and other concessions, required to be provided for the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

(RR) dated 9.8.2016, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands hereby makes the following Amendments to the Recruitment Rules to Group-A (Gazetted) post of Research Officer in the Directorate of Economics & Statistics, Andaman and Nicobar Administration published in the A & N Extraordinary Gazette Notification No.67 dated 19th March, 2010:-

#### 1. Short title and commencement :-

- (i) These rules may be called the Andaman and Nicobar Administration (Research Officer) Recruitment (Amendment) Rules, 2017.
- (ii) They shall come into force on the date of their publication in the Official Gazette.

#### **AMENDMENTS**

2. (i) The existing Column-4 of the Schedule appended to the Recruitment Rules (hereinafter called for brevity as the "said Recruitment Rules") shall be substituted as under:-

Level in the Pay Matrix

Level-10 (Rs. 56100-177500)

(ii) The existing entries against Column-12 of the Schedule shall be substituted as under:-

#### Promotion:

From amongst Statistical Officer/Evaluation Officer in Level-7 (Rs. 44900-142400) in the Pay Matrix with Three Year's regular service in the grade rendered appointment thereto on regular basis.

Note: Where Juniors who have completed their qualifying/ eligibility service are being considered for promotion, their Seniors would also be considered provided they are not short of the requisite qualifying/ eligibility service by more than half of such qualifying/ eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next Higher Grade alongwith their Juniors who have already completed such qualifying/ eligibility service.

#### Deputation:

Officers under the Central/ State Govts./UTs except Officers of Department of A&N Administration:

- (a)(i) holding analogous post on regular basis in the Parent Cadre/Department; (OR)
- (ii) with Two Year's service in the grade rendered after appointment thereto on a regular basis in Level-8 (Rs. 47600-151100) in the Pay Matrix or equivalent in the Parent Cadre/Department; (OR)
- (iii) with Three Year's service in the grade rendered after appointment thereto on a regular basis in Level-7 (Rs. 44900-142400) in the Pay Matrix or equivalent in the Parent Cadre/Department; And
- (b) Possessing the Educational Qualifications and Experience prescribed for Direct Recruits.

<u>Note:</u> The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for Appointment on Deputation.

Similarly Deputationist shall not be eligible for consideration for appointment by promotion. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/ Department of the Central Government shall be not exceeding 56 years as on the closing date of receipt of application.
