**NOTIFICATION**

Port Blair dated the 28<sup>th</sup> November 1996.

No. 97(D)/96-F.No. CWLW/WL/31/1219 – Whereas, in exercise of the powers conferred by sub-section (1) of Section 35, read with sub-section (29) of section 2 of the Wildlife (Protection) Act, 1972 (Act No. 53 of 1972), the Lieutenant Governor (Administrator), Andaman and Nicobar Islands by reasons of the ecological, faunal, floral, geo-morphological and Zoological association or importance, has declared his intention vide A & N Administration's Notification No. Silva/G/88 dated 13<sup>th</sup> November, 1979, to constitute the area specified in the schedule to this Notification as "National Parks" for the purpose of protecting, propagating and developing Wildlife therein and the environment;

And, whereas the above said area has been declared as Reserved Forest under the provisions of the Indian Forest Act, 1927 vide A & N Administration's Notification No.59/G/635 dated 17th April 1963; and No.115/47-5/60/DH dated 8th September 1963;

Now, therefore, in exercise of the powers conferred by sub-section (4) of Section 35 read with sub-section (29) of Section 2 of the Wildlife (Protection) Act, 1972, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, hereby declares the above said area as specified in the schedule below as "**National Parks**" with effect from the date of publication of this Notification in the official gazette.
