### xiv) **Broad scope of the proposal**

Due to massive earthquake followed by the Tsunami which was occurred on 26<sup>th</sup> December 2004, part of the approach jetty of 116.00 mtrs out of 201.00 mtrs was washed away and same has been re-constructed during the year 2005-2006. Since the remaining 85mtrs approach jetty had also suffered structural damages due to liquefaction effects of the earth quake and agedness of the structures, this remaining portion of 85.00 mtrs also has been reconstructed with bored cast-in-situ piles by raising to a height of (+) 4.00 mtrs during the year 2009-2010. The berthing jetty of length 110.00 x 21.00 mtrs, which was constructed prior to 1992 in different stages also has suffered damages due to liquefaction effects of the earthquake and Tsunami was neither been strengthened nor re-constructed. The present jetty is not feasible/ advisable to rise/strengthen the existing berthing jetty. So as to avert any eventualities the extension of berthing jetty by 50m will improve the feasibility the Inter Island passengers ships as well as cargo vessels.
