(SCHEME OF ASSISTANCE TO DISABLED PERSONS FOR FITTING OF AIDS/APPLIANCES)

ADIP Scheme is one of the major initiatives of the Ministry of Social Justice & Empowerment, Govt. of India to assist the needy Divyangjan in accessing durable, sophisticated and scientifically manufactured, modern, standard Aids and Appliances to promote their physical, social and psychological rehabilitation.

ELIGIBILITY CRITERIA

A person with Disabilities fulfilling the following conditions would be eligible for assistance under ADIP Scheme:

- i. An Indian citizen of any age.
- ii. Holds a 40% Disability Certificate.
- iii. His monthly income from all sources not exceeding Rs. 20,000/- per month.
- iv. In case of dependents, the income of parents/guardians should not exceed Rs. 20,000/- per month.
- v. Who has not received assistance during the last 3 years for the same purpose from any source. However, for children below 12 years of age, this limit would be one year.

Note:- Income certificate of beneficiaries staying in orphanages and half-way homes etc. will be accepted on certification of District Collector or Head of the organization concerned.

Total Income	Amount of Assistance
(i) Up to Rs. 15,000/- per month (ii) Rs.15,001/- to Rs. 20,000/- per Month	(i) Full cost of aid/appliance (ii) 50% of the cost of aid/appliance


Beneficiaries fulfilling the above criteria may apply to Director, Directorate of Social Welfare in the format of application form attached.

DOCUMENTS REQUIRED FOR REGISTRATION

- Disability Certificate certifying minimum 40% disability issued by the authorized Medical officer of Andaman & Nicobar Administration.
- 2 Nos. Passport Size Photographs of the applicant
- Income Certificate from Revenue Authority in the space provided in the form
- Self attested copy of Aadhar Card is mandatory.

Eligible and interested Divyangjan are requested to submit the filled application form in the Department of Social Welfare, Goalghar or in the Office of the CDPO Concerned or to the Anganwadi Worker by 30th September 2020
