Samrat Roy, Hon'ble Chief Judicial Magistrate, underlined the critical need to sensitize Judiciary, Police, and institutional staffs to adopt child friendly procedure in dealing with cases under the POCSO Act. He emphasizes on capacity building of frontline functionaries and timely coordination between all stakeholders involve in Child Protection.

Manoj Kumar Meena, IPS, Senior Superintendent of Police, South Andaman, underscored the importance of enhancing security and safety protocols, such as the installation of CCTV cameras, maintenance of visitor registers, and mandatory police verification for all CCl staff members, including support staff and contractual employees.
