

## Qualifying Criteria

Following certificate / documents to be uploaded mandatorily

1. Scanned copy of the documentary proof of Shop Registration in A & N Islands.
2. Scanned copy of MSME registration certificate under relevant category by those firms who seek exemption in EMD/Bid Security.
3. Scanned copy of past experience for **One year** if any in providing for supply of Grocery/SNP Items to any Govt. Departments/Organizations/Public undertaking /Autonomous bodies/company etc.
4. Scanned copy of FSSAI (Food Safety and Standards Authority of India) registration certificate if any.

## TERMS & CONDITIONS

1. The bidders have to quote rates for supply and distribution of all SNP items for 207 Anganwadi Centers under ICDS Urban Project.
2. The rates for each item shall be filled in the prescribed format available online in the e-proc portal viz. <https://eprocure.andamannicobar.gov.in> and should be uploaded online at the e-proc portal before the closing date.
3. Scanned copy of the valid GST Registration Certificate/ GSTIN shall be submitted as proof of tax registration.
4. The bidders are requested not to tamper the bid form or cells in the spread sheets provided for quoting.
5. The spread sheet should be downloaded on the local system then fill it up, save and upload without changing the file name or structure.
6. The successful bidder will have to deposit **performance security @ 3%** of the total value of contract in form of A/c payee Demand Draft, FDR, Bankers Cheque or Bank Guarantee in favour of **Child Development Project Officer, ICDS Urban Project**. The Performance Security shall remain valid for a period of 60 days beyond the terms of the contract period. On submission of the performance security, the EMD will be returned to the firm.
7. The successful bidder will have to enter into an agreement with the department for successful execution of the contract.
8. The rate(s) quoted should be inclusive of delivery charges for delivery of item at each Anganwadi Centre for a period of one year or till the finalization of tender for FY 2025-26.
9. The L1 shall be evaluated on the basis of evaluation of item wise amount quoted for all the items in the bid.
10. The quantity of SNP articles may vary depending upon addition and deletion of Beneficiaries in each month at Anganwadi Centre.
11. Anganwadi wise supply order shall be issued every month to the supplier to supply the items in the respective Anganwadi Centre's.
12. The rates quoted by the firms for the items should be final inclusive of all taxes/ charges along with GST as applicable.
13. In case the firm fails to supply the items within the delivery period (**10 days**), liquidated damaged charge will be charged @0.5% per week to a maximum of 5% on the total cost of supply order, which will be deducted from the monthly bill / final payment. In case the firm fails to supply the items, the Performance Security of the firm shall be forfeited to Government account and other action as deem fit shall also be initiated against the firm.
14. The SNP Items supplied by the L1 supplier should meet the standard of FSSAI (Food Safety and Standards Authority of India). Random testing of the quantity and quality of items supplied by the L1 bidder to the AWCs shall be done by an appropriate authority authorized by Directorate of Social Welfare.



15. L1 supplier shall distribute the items at 207 Anganwadi centre within 10 days of receipt of supply order.
16. It is the sole responsibility of the L1 supplier to deliver the SNP items in good condition at each Anganwadi Centre. If the SNP items are found damaged, stale, substandard or low quality then the same should be replaced immediately with fresh items by the supplier without any additional cost to the buyer. Failing to replace the items in the stipulated time, the L1 supplier may be blacklisted and the contract shall be cancelled without any notice.
17. The L1 Supplier shall submit bills in each month after delivery of items at all Anganwadi Centres along with supporting documents viz. delivery challan etc.
18. The bills shall be settled by the Child Development Project Officer (UP) subject to the fulfillment of all terms and conditions. The bills will be settled within 01 (One Month) from the date of receipt of bills in the office of the Child Development Project Officer subject to availability of fund.
19. The contract shall be initially for 01 year (12 months) from the date of acceptance and shall be extended for 3 months on mutual consent.
20. The Child Development Project Officer, ICDS (Urban Project), A & N Administration reserve the right to reject or accept any tender/ Quotation in full and partly without assigning any reason thereof.
21. Declaration by the bidder in (Annexure "A") that it has not been Banned / Black listed by any Central / State Government / Port / PSUs. Any entity which has been barred by the Central / State Government / Port / PSUs from participating in any project and the bar subsists as on the Bid Due Date, would not be eligible to submit a Bid.
22. Declaration by the bidder (Annexure "B"), than an undertaking that all the pages of etender documents have been read, understood and agreed within the Terms & Conditions.
23. Earnest Money Deposit will be refunded to unsuccessful tenderers after the award of contract. No interest will be allowed on the Earnest Money from the date of its receipt until it is so refunded.
24. Clarification if any required for finalization of tender shall be obtained prior to finalization of the tender.
25. Any unresolved issue shall be subject to the jurisdiction of the competent court at Sri Vijaya Puram.
