6. Detailed Project Report comprising of:
  - i. Written detailed justification for the required conversion
  - ii. Energy consume and energy consumption measures proposed to be adopted.
  - iii. No. of person employed, employment generation potential of the project and contribution to local economy.
  - iv. Environment and ecological impact assessment – Mechanism of waste disposal, Source of water supply and adoption of water conservation / water harvesting measures.
