Sir,

In Continuation to this office letter cited above, it is to inform that, you are permitted to cut the black top portion of road as well as road side berm on or before For purpose connection, in consultation with Assistant Engineer, SD No. , subject to the following conditions:-

1. The road should not be closed for traffic and digging of the road should be done in parts, so that vehicles can use rest of road for smoothly.
2. During the time of cutting the road/berm necessary barricade should be provided and if any portions remain unfilled during night, danger sign should be provided. During day time necessary red flag and caution board should be prominently exhibited, responsibility for any danger due to non observance of the above precautions will be rest on you. The work when taken up should be got completed quickly and also not to cause any inconvenience to the public. A board showing name of ongoing action shall also be displayed during work.
3. If the road to be closed during the work, then the prior permission of the Deputy Commissioner is to be obtained and necessary procedure to be adopted e.g. press note etc. for appraising of general public.
4. Prior intimation may be given to PBMC, Electricity Department and BSNL, Port Blair to execute of work to avoid any disturbance of water supply, electricity and telephone service.
5. During the execution, if any services are disturbed, that is pipe lines/Electric cables/Telephone cables etc., responsibility for rectification of the same will rest on you.
6. Cutting of road/berm to be taken up after giving prior intimation to the Assistant Engineer- /SAD of this Division.
7. Additional reinstatement charges shall be paid to this department, in case if any extra damage/cutting of black top road/road side berm.
